The GEMS tabulation system does not alert/advise users if a foreign (DRE Memory Card that was not created in the current database) memory card is being uploaded. The results from the card is not tabulated into the vote count for the current This situation is not noticeable until such time as an attempt is made to export the results form GEMS. This situation precluded any results export from the GEMS server. The foreign card is not readily apparent amongst all the other DRE Memory cards that have already been uploaded into GEMS. It then become an exercise of trial and error to identify the foreign memory cards uploaded into the incorrect election and remove it. This resulted in our having to create a back-up GEMS database for this election and then use this back-up database to test remove one memory card at a time and then attempt to export a file after each removal. Using trial and error as a method, once we removed the foreign DRE Memory Card from this back-up GEMS and identify the
