SUBJECT: FY2017 Final Adopted Budget

At the recess meeting on January 18, 2017, the Board of Commissioners reviewed and approved the final adopted operating budget and budget resolution for FY2017. Below is a summary of the changes to the proposed budget and a request to identify a funding source to supplement funding to existing programs.

The accompanying booklet to this memo is the FY2017 Final Adopted Budget. It includes the proposed budget in addition to all subsequent changes approved by the Board of Commissioners.

APPROVED CHANGES TO THE PROPOSSED FY2017 BUDGET

GENERAL FUND

Revenue:

1) Increase FY2017 Prior Year Property Tax for Public Utilities by \$9.5 million (non-recurring)

The Board of Commissioners approved an increase to utility property tax in 2017. This amount was previously anticipated to be collected in FY2016, but was not collected. This is a revenue collection timing issue.

2) Decrease in FY2017 prior year Property Tax revenue by \$2 million (recurring) The Board of Commissioners approved to lower prior year Property Tax revenue in FY2017. Property Tax collections in FY2016 came slightly higher than projected by \$1 million. The mid-year projection assumed a slightly lower collection rate when compared to the actual amount received (94% versus 94.47%). Additionally, the mid-year FY2016 projection assumed marginally higher tax billings than actuals by approximately \$1 million. This difference is the result of appeals settlements which have reduced billings. The effect of higher collections in FY2016 than originally projected and lower tax billings than originally projected have an overall reduction effect in FY2017 revenue of \$2 million. This is a preliminary estimate and may require further adjustment early in FY2017 as billing and receivable reports are received from the Tax Commissioner.

Expenditures:

Increase Registration and Elections Department's budget by \$414,000 (non-recurring).

The Board of Commissioners approved an increase to the Registration and Elections Department's budget to conduct a special election to replace Tom Price, US Representative in the 6th district, who has been nominated to serve as the new Secretary of Health and Human Services under President Trump.

- 2) Increase Non-Agency's budget by \$ 2,510,000 million (non-recurring). The Board of Commissioners approved an increase to the Non-Agency's budget to create a reserve to cover unexpected financial pressures associated with the incorporation of South Fulton. These may include expenditure pressures such as contract termination clauses and settlement of compensated absences liabilities associated with Public Works (Transportation) and Police employees that could be affected by the incorporation. Some of these funds could also be used to fund the county wide youth crime prevention program.
- 3) Increase Non-Agency's budget by \$400,000 (non-recurring). The Board of Commissioners approved an increase to the Non-Agency's budget to create a reserve for compensated absences for employees from the Behavioral Health Department in the General Fund. The new service delivery approach will affect a number of employees and the County could be required to settle the outstanding compensated absences liabilities for these individuals.
- 4) Increase the Board of Commissioners' budget in 2017 by \$13,200 (recurring). The Board of Commissioners approved an increase to Commissioner Arrington's budget to enhance the salary and corresponding benefits for two staff.
- 5) Increase to Juvenile Court's budget in 2017 by \$318,978 (recurring). The Board of Commissioners approved an increase to the Juvenile Court's budget to allow for the addition of four (4) full time guardians ad litem (GAL). This additional funding will enhance the GAL unit, which is currently exceeding capacity and there is limited number of volunteers available to supplement existing staff.
- 6) Increase the Office of County Manager's budget by \$300,000 for marketing countywide economic development efforts (non-recurring).
 The Board of Commissioners approved an increase to the budget for the Economic Development program within the office of County Manager's budget. The funding will be used to boost the marketing activities of Select Fulton, which focuses on enhancing the economic viability and quality of life in Fulton County.
- 7) Increase the Aging and Youth Department's budget by \$500,000 (non-recurring). The Board of Commissioners approved an increase to the budget of the Aging and Youth Department for multiple operational needs in the aging program. Funding will address needs in the following areas: food security, the water therapy program, the Inhome Services program, Home Delivered Meals, and the Adult Day Care program.

8) Increase the Housing and Community Development Department's budget by \$500,000 (non-recurring).

The Board of Commissioners approved an increase to the funding for the Community Service Grants in the Housing and Community Development Department. This funding will be used to develop and manage a program to address safety and self-sufficiency issues among the County's youth with the help of non for profit organizations and other stakeholders.

- 9) Increase the Arts and Culture Department's budget by \$130,000 (non-recurring). The Board of Commissioners approved an increase to the funding for Contract for Services program in the Arts and Culture Department's budget by \$130,000 over the FY2016 funding amount from the General Fund. With this increase to the Arts and Culture General Fund budget, excluding \$200,000 for the nature centers transferred from the Health Department, the overall county wide expenditure to the Contract for Services program will remain at the same level as 2016, when taking in consideration all funding sources.
- 10) Increase Non-Agency's budget by \$ 1,000,000 million (non-recurring). The Board of Commissioners approved an increase to the Non-Agency's budget to set aside funding to be used for the county wide youth crime prevention program. The funding will be allocated to those departments participating in the program once a comprehensive plan is submitted for review and consideration. During the recess meeting on January 18, 2017, the Board of Commissioners gave conceptual approval to the plan presented. The Administration recommends funding the county wide crime prevention program estimated of \$2.5 million as follows;
 - \$1 million set aside in the budget for this purpose
 - Repurpose \$1 million in funding set aside for unexpected financial pressures as a result of the incorporation of South Fulton (item 2 above) for this purpose
 - Utilize the \$500,000 for the Community Service Grants for youth selfsufficiency and safety issues in the Housing and Community Development Department (item 8 above)
- 11) Reallocate funding included in the proposed budget for the Non-Agency to agencies in the justice system participating in the Justice Reinvestment Initiative for a combined amount of \$6,403,423 (non-recurring).

The Board of Commissioners approved the reallocation of funding from Non-Agency to a number of justice agencies per approval of the FY2017 Justice Reinvestment Plan. The allocation is a follows;

12) Identify funding from the operating budget by \$50,000 to supplement the Arts and Culture Department's budget.

Action Required:

The Board of Commissioners requested the Administration identify additional funding in the FY2017 budget to supplement Contract for Services funding to expand Arts and Culture related activities.

The Administration recommends using part of the funding included in the Non-Agency's budget to create a reserve to cover unexpected financial pressures associated with the incorporation of South Fulton (point 2 above) to fund the supplemental funding of \$50,000 for Contract for Services in the Arts and Culture Department.

13) Identify funding from the operating budget by \$200,000 to supplement the Disability Affairs Programing and Compliance budget within the County Manager's Department. Action Required;

The Board of Commissioners requested the Administration identify additional funding in the FY2017 budget to ensure compliance with the American and Disability Act (ADA) and to supplement funding for language translation services.

The Administration recommends using part of the funding set aside for capital facilities in the Non-Agency's budget to be utilized for the ADA assessments for County facilities in the amount of \$150,000. The Administration recommends utilizing funding in the Non-Agency's budget for Network Telecom services to be used to fund language translation services on an as needed basis.

SOUTH FULTON

Revenue:

1) Increase 2017 Property Tax Revenue for Prior Year Public Utilities by \$1.2 million (non-recurring).

The Board of Commissioners approved to increase utility property tax revenue in 2017. This amount was previously anticipated to be received in FY2016, but was not collected. This is a revenue collection timing issue. Decrease in FY2017 prior year Property Tax revenue by \$591,716 (recurring).Action Required:

The Board of Commissioners approved to lower prior year Property Tax revenue in FY2017. Property tax collections in FY2016 came slightly higher than projected at 93% of billings, compared to a 91% collection estimated during the mid-year projection. The timing difference of collections is causing the reduction in the FY2017 revenue number.

3) Increase the Property Tax recovery amount from the new city for FY2017 by \$604,635 (non-recurring).

The Board of Commissioners approved to increase the Property Taxes Recovery amount by \$604,635. The shift in Property Tax Utility revenue between FY2016 and FY2017, lower prior year Property Tax projected for FY2017, and a lower than projected fund balance in FY0216 resulted in a higher Property Tax Recovery amount from the new city than originally projected.

AIRPORT FUND

Expenditures:

 Move the budget of \$2,828,477 (recurring) from the Real Estate and Asset Management Department to the Public Works Department.

The Board of Commissioners approved the reallocation of funding in fund 200 (Airport Fund) from the Real Estate and Asset Management Department to the Department of Public Works. The change will better align the responsibilities and operations of the resources utilized at the Airport with the functions of the Department of Public Works.

STORMWATER FUND

Expenditures:

1) Increase the budget of the Department of Public Works by \$16,800 (non-recurring) for FY2017.

The Board of Commissioners approved to increase the budget for the Department of Public Works to re- appropriate unspent funds from FY2016 that will be used in FY2017 to pay contractual agreements.

RISK MANAGEMENT FUND

Expenditures:

 Increase the budget of Non-Agency – Direct Charges and Settlements by \$8.5 million (non-recurring).

The Board of Commissioners approved to increase the budget for Non-Agency – Direct Charges and Settlements to re-appropriate funds unspent during FY2016 for potential litigation and risk exposures during FY2017. The practice has been to fully appropriate available fund balance for use in handling any unknown lawsuits that may arise during the year.

WOLF CREEK FUND

Expenditures:

1) Decrease the budget for the Arts and Culture Department by \$161,281. The Board of Commissioners approved to decrease the budget for the Arts and Culture Department. Actual FY2016 expenditures were higher than the mid-year projection, which resulted in a lower fund balance than projected. In order to maintain this enterprise fund balanced, the FY2017 expenditure budget needs to be reduced.

At the recess meeting on January 18, 2017, the Board of Commissioners agreed to approve the Wolf Creek budget as presented. It was noted that upon approval of a pending contract with an external vendor, who will take over day-to-day operations of the Wolf Creek Amphitheater, that a new budget structure could be presented. At that point, the Wolf Creek budget could be amended, if necessary.
